I, S. Annette Spindlove, North Ogden City Recorder, hereby give notice in accordance with 20A-5-405 of the Utah Code for the General Election to be held on November 5, 2013 for all eligible registered voters. Persons wishing to vote must be 18 years of age and a registered voter in North Ogden City at least 30 days prior to the election. All voters are required to present valid voter identification. To view valid forms of voter identification, view our website at [www.northogdencity.com](http://www.northogdencity.com) on the home page click the elections tab. Voters who do not have identification with them can cast a Provisional Ballot and then present valid voter identification to the county clerk within five business days after the election. If your name or address has changed, you will be required to vote a Provisional Ballot and will have to show proof of residency for the new name and/or address at that time. We begin plowing snow when there is an accumulation of 3” or more. For those storms that are less than 3” we will salt the main road, large hills and school zones only.

With a storm that lays down 3” of snow and then stops it will take approximately 8-10 hours for the plows to clear the snow from every area in the City but if the snow continues beyond 3” the time is increased roughly 2 hours per inch. Please know that we are doing our best to meet the snow removal needs of the city as quickly as possible.

**Please be patient in cleaning your driveways and do not put your snow in the roadways as this creates a road hazard. When clearing your driveway, please put the snow on the right side of your driveway so when the plows do come by they will push the snow away from your driveway.**

**Additionally, please remember there is no parking on any city street from midnight to 6:00 am or within 24 hours of a snowstorm.**

We ask your help in being patient and driving safely. Please be sure that your vehicles have proper maintenance and that you decrease your speeds.

MESSAGE FROM THE CHIEF

Parking always seems to be one of the ordinances people misunderstand or simply choose to ignore. Recently, I have received complaints about parked trailers, vehicles blocking sidewalks, or simply old vehicles left on the street.



The North Ogden City Ordinances are clear about parking on City streets. Title 7, Chapter 3, directs the following:

1. A vehicle cannot be parked in a manner that blocks free passage of other cars or pedestrians.
2. A vehicle may not be parked with the left side of the vehicle next to the curb unless it is a one-way street.
3. Vehicles must be parked parallel to the curb. Drivers may not just pull straight into a cul-de-sac and park at an angle.
4. Vehicles may not be parked with a “for sale” sign on any street.
5. Semi-trucks/trailers and commercial vehicles cannot be parked on a public street except to deliver goods.
6. Recreational Vehicles: May not be parked upon any street within a residential district for a period of more than two (2) consecutive days and no more than ten (10) days total during any calendar month without a special permit from the city.
7. Please respect the handicap and red zone areas properly posted throughout the city.
8. Winter Parking Regulations:
  1. It is unlawful to park, or allow to be parked any vehicle on any public street or roadway in the city between the hours of twelve o’clock (12:00) midnight and six o’clock (6:00) A.M. from November 15 through March 15 of each year, except physicians or emergency vehicles in emergency situations. \*Winter Parking Regulations are in force whether it’s snowing or not.
  2. It is unlawful to park, or allow to be parked, any vehicle on any public street or roadway in the city during any snowstorm or within twenty four (24) hours following the cessation of snow after any snowstorm.
9. Whenever a police officer discovers a vehicle in violation of the parking ordinance, that officer is authorized to have the vehicle towed at the vehicle owner’s expense.

The parking ordinances are designed for safety and keeping the city clear of unreasonably parked vehicles.

I appreciate the sensitivity that neighbors have when they begin to have parking issues. Many awkward feelings can develop over parking that makes living close to one another difficult. We at the police department are tasked with the responsibility of complaints and protecting the complainant, which we will do.

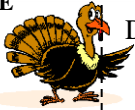

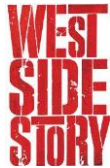

It's time again to renew your dog's license. Licenses can be renewed at the North Ogden City Police Department, 515 E. 2600 N. Office hours are Monday-Friday 8am-5pm, excluding holidays. License applications are available for your convenience on the city's webpage, [www.northogdencity.com](http://www.northogdencity.com), or they can be picked up and filled out at the police department front desk.



All North Ogden City dog licenses are set to expire December 31<sup>st</sup>, 2013, and are due to be renewed. License renewals can be done anytime starting November 1<sup>st</sup>. The owner or caregiver of any dog not licensed by March 1<sup>st</sup>, 2014 will be in violation of North Ogden City Ordinance 6-1-3(A), a class C misdemeanor. Late fees will accrue for all licenses not renewed by March 1<sup>st</sup>.

Sadly, every year there are residents who face late fees and citations because they put off renewing their dog licenses until after the March 1<sup>st</sup> deadline. Please, do not procrastinate.



**COMMUNITY EMERGENCY RESPONSE TEAM**

Over the years, North Ogden has experienced several flood events resulting from heavy rain or snowmelt. Neighboring communities have also experienced flooding that resulted from canal breaches or other calamities. The North Ogden Community Emergency Response Team (C.E.R.T.) will be hosting sandbag training on Saturday, November 9<sup>th</sup>, at 10am at the North Ogden City Shops, 332 E. Pleasant View Dr. Weber County's Emergency Manager, Lance Peterson will be on hand to teach proper filling and stacking techniques. Lance was instrumental in Weber County's response to the spring, 2011 flooding. This is an excellent opportunity to learn from a pro, and gain a valuable skill that could come in handy during next spring's runoff or during a flood event. The training is expected to take 1-2 hours. Everyone is invited. Bring gloves and a shovel.
