RADON GAS HAZARDS



Radon is a radioactive gas that has no smell, taste, or color, and exposure over time causes lung cancer. To date, the number of lung cancer fatalities caused by radon gas make radon gas Utah's most deadly geologic hazard. Geologic conditions directly affect indoor radon gas concentrations; however, indoor radon gas concentrations are highly dependent on building construction

methods. Radon comes from the natural decay of uranium which is found in nearly all rock and soil. When geologic and building conditions are favorable, the potential for high indoor levels of radon gas increases.

NORTH OGDEN CITY TO START OWN GARBAGE PICK UP:

WHY?



When looking at renewing our contract with Republic Services, the Public Works Department, City Council, and Mayor agreed that the increase to our contracted services with them would not be beneficial to our city and would result in a rate increase to our residents. Instead, the Public Works Director started looking into the cost to bring garbage pick-up in house and found it to be the same cost that we are presently paying for Republic Services to do it.

WHY DID THIS CANCEL RECYCLING?

Over the past year the recycling market has taken a huge hit. In the beginning we received a rebate for participating in the recycling program, but as the years have gone on, recycling standards have become stricter causing 75-80% of residents recycling cans to be taken to the dump. With each of these trips to the dump, we were being charged \$85 causing a loss to our city.

ISN'T THERE ANOTHER OPTION?

Unfortunately there are no alternative options that would keep or lower the cost of recycling from what we are presently seeing from Recycled Earth at this time. This problem is an industry problem not just a North Ogden City problem.

We have looked at other recycling companies, but we would pay about the same cost as well as the added cost of hauling the recycling much further than we presently do. Those hauling fees would result in an increase to residents utility bills.

WHAT DO I DO WITH MY RECYCLING CAN?

Moving forward, the blue can that was previously used for recycling will be used as an overflow garbage can. It will still be emptied every other week (link to overflow garbage calendar on website) as it always has been.
