ORDINANCE RDA 2023 -

AN ORDINANCE OF THE NORTH OGDEN REVELOPMENT AGENCY AMENDING THE BUDGET FOR FISCAL YEAR 2023-2024

WHEREAS; the North Ogden Redevelopment Agency has reviewed projected needs and recommended budgets and desires to adjust the current fiscal year budget; and

WHEREAS; the North Ogden Redevelopment Agency wishes to authorize the expenditure of funds left unexpended during the previous fiscal year; and

WHEREAS; the North Ogden Redevelopment Agency Board held a public hearing to take public comment regarding the budget on December 12, 2023; and

NOW THEREFORE, BE IT RESOLVED by the North Ogden Redevelopment Agency Board that the Redevelopment Agency Budget for Fiscal Year 2023-2024 be amended as follows:

SECTION 1: The North Ogden Redevelopment Agency Board hereby adopts the Amended Budget for the Fiscal Year 2023-2024 as incorporated herein and established as the Fiscal Year 2023-2024 Amended Budget.

SECTION 2: Severability. In any section, or provision of this Ordinance is held, invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts, and provisions of the Ordinance shall be severable.

SECTION 3: Effective Date. This Ordinance shall become effective immediately upon its passage.
