

## **ORDINANCE 2020-27**

### **ESTABLISHING A TIME AND PLACE FOR HOLDING REGULAR MEETINGS FOR THE 2021 CALENDAR YEAR.**

Be it ordained by the governing body of the municipality of NORTH OGDEN CITY.

**SECTION 1. TIME AND PLACE OF REGULAR COUNCIL MEETINGS, PLANNING COMMISSION MEETINGS, REDEVELOPMENT COMMITTEE MEETINGS, COMMERCIAL DEVELOPMENT COMMITTEE MEETINGS, GENERAL PLAN STEERING COMMITTEE MEETINGS, ECONOMIC COMMITTEE MEETINGS, PUBLIC SAFETY COMMITTEE MEETINGS, ART'S GUILD MEETINGS, AND AUDIT COMMITTEE MEETINGS** The governing body shall conduct regular meeting(s), which shall be held as follows: The second and fourth Tuesday of every month shall be a Regular meeting unless otherwise noted and the first Tuesday of every month for a work session as needed and the Planning Commission aka The Land Use Authority shall conduct regular meeting(s), which shall be held as follows: The first and third Wednesday of every month shall be a Regular meeting unless otherwise noted.

The RDA, CDA, ART'S GUILD, AND AUDIT COMMITTEE'S will meet only when called upon.

The General Plan Steering Committee will meet the fourth Wednesday of every month unless otherwise noted at 6:30 pm in the City Council Chambers 505 E 2600 N, North Ogden, Utah.

The Economic Development Committee will meet the third Tuesday of every month, unless otherwise noted at 6:30 pm in the City Council Chambers 505 E 2600 N, North Ogden, Utah.

The Public Safety Building Committee will meet the second Wednesday of every month unless otherwise noted at 6pm in the Court Room at 515 E 2600 N, North Ogden, Utah.


This schedule is to be followed for the entire 2021 calendar year unless further notice is given. Any meetings that fall on an election day or a holiday will be canceled.

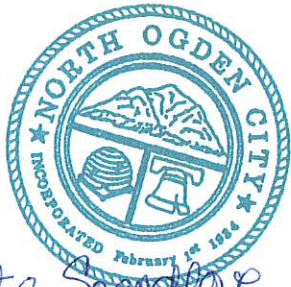
