

ORDINANCE 2021- 18

AN ORDINANCE AMENDING THE NORTH OGDEN CITY CODE REQUIRING THE EXPENDITURE OF PROPERTY TAXES ON PUBLIC SAFETY NEEDS

WHEREAS: The City has been given authority by the state to enact ordinances and regulate the expenditures of taxes received; and

WHEREAS: As a vital and critical service to North Ogden City residents North Ogden City wishes to provide for guaranteed funding dedicated to the public safety needs of the City; and

WHEREAS: The City has been given the authority to levy a property tax against all properties within the municipal boundaries; and

WHEREAS: The City desires to limit the expenditure of all property taxes received to public safety purposes.

NOW THEREFORE, BE IT ORDAINED by the North Ogden City Council that the North Ogden City Code be amended as follows.

SECTION 1: The North Ogden Code Title 3 Chapter 2 Article D be enacted.

ARTICLE D: MUNICIPAL PROPERTY TAX EXPENDITURE

3-2D-1: TITLE

This article shall be known as the Municipal Property Tax Expenditure Ordinance of North Ogden City

3-2D-2: Purpose

The purpose of this article is to provide a guaranteed funding mechanism for some or all of the public safety needs of North Ogden City

3-2D-3: Tax Levied

Pursuant to Utah State Law the North Ogden City Council is authorized to establish a property tax rate on an annual basis.


3-2D-4: Expenditure of Property Tax Proceeds

During the annual budget process the finance director shall provide the City Council will evidence, whether directly or by other means to verify that the expenditures on public safety meets or exceeds the annual property tax levy imposed on properties in North Ogden City. Should property tax revenues ever exceed the expenditures in the final budget on public safety needs the Council should amend the property tax rate to not exceed the expenditures.

SECTION 2: This ordinance shall take immediate effect.


