

ORDINANCE 2021-41

ESTABLISHING A TIME AND PLACE FOR HOLDING REGULAR MEETINGS FOR THE 2022 CALENDAR YEAR.

Be it ordained by the governing body of the municipality of NORTH OGDEN CITY.

SECTION 1. TIME AND PLACE OF REGULAR COUNCIL MEETINGS, PLANNING COMMISSION MEETINGS, REDEVELOPMENT COMMITTEE MEETINGS (RDA), COMMERCIAL DEVELOPMENT COMMITTEE MEETINGS (CDA), ECONOMIC COMMITTEE MEETINGS (EDC), GENERAL PLAN ADVISORY COMMITTEE MEETINGS, ART'S GUILD MEETINGS, AND AUDIT COMMITTEE MEETINGS The governing body shall conduct regular meeting(s), which shall be held as follows: The second and fourth Tuesday of every month shall be a regular meeting and the first Tuesday of every month may be used for a work session as needed. The Planning Commission (The Land Use Authority) shall conduct regular meeting(s), which shall be held as follows: The first and third Wednesday of every month shall be a Regular meeting unless otherwise noted.

The governing body meeting(s) shall begin promptly at 6:00 pm Mountain Standard Time and at 6:00 pm during Mountain Daylight Time.

The Planning Commission, aka The Land Use Authority meeting(s) shall begin promptly at 6:00pm during Mountain Standard Time and at 6:00pm during Mountain Daylight Time.

The RDA, CDA, ART'S GUILD, AND AUDIT COMMITTEE'S will meet only when called upon.

The Economic Development Committee may be held on the third Tuesday of quarterly, starting in January at 6:00 pm in the City Council Chambers 505 E 2600 N, North Ogden, Utah.

This schedule is to be followed for the entire 2022 calendar year unless further notice is given. Any meetings that fall on an election day, a holiday, or no agenda items, then the meeting may be canceled.
