

## ORDINANCE 2023-14

### AN ORDINANCE OF THE NORTH OGDEN CITY COUNCIL FOR AMENDING CHAPTER 10-2 FIRE CODE FOR THE ADOPTION OF THE INTERNATIONAL FIRE CODE, 2021 VERSION WITH APPENDICES.

**WHEREAS** North View Fire District has made recommendation for the adoption of the 2021 International Fire Code with Appendices;

**WHEREAS** North View Fire District provides the fire public safety services for North Ogden City;

**WHEREAS** North Ogden City finds that such an amendment is in the best interest of the City.

**NOW, THEREFORE**, be it ordained by the North Ogden City Council the following:

**SECTION ONE:** The Section 10-2-1 of the North Ogden City Municipal Code shall be and hereby amended to the following:

**10-2-1-A Adopted.** Fire Code: There is adopted by the City of North Ogden for the purpose of prescribing regulation governing conditions hazardous to life and property from fire, hazardous materials or explosion, that certain code known as the International Fire Code (IFC), 2021 Edition including appendices, as promulgated by the International Code Counsel; save and except such portions as are deleted, modified or amended by CCNO 10-2-5 of this chapter, are adopted and incorporated as fully as if set out at length herein, and from the date on which the ordinance codified in this chapter shall take effect, the provision thereof shall be controlling within the limits of the city.

**10-2-1-B Adopted.** Appendices:

1. The blanks in the following sections of the 2021 international fire code are filled in as follows:
  - a. The blank in section 101.1 should read "North Ogden City";
  - b. The first blank in section 1012.4 should read "misdemeanor";
  - c. The second blank in section 1012.4 should read "\$299.00";
  - d. The third blank in section 1012.4 should read "180 days"; and
2. Adoption of Appendices to the International Fire Code. The following Appendices to the International Fire Code are hereby adopted as if they were fully integrated into the International Fire Code. Any activity which is governed by the terms of the International Fire Code shall also comply with the terms of these Appendices:
  - a. Appendix A: Board of Appeals
  - b. Appendix B: Fire-flow Requirements for Buildings
  - c. Appendix C: Fire Hydrant Locations and Distribution
  - d. Appendix D: Fire Apparatus Access Road -Appendix D to the International Fire Code is also hereby adopted, provided that if the terms of Appendix D are found to be in conflict with the grading and road standards of the City's Public Works

Standards or any equivalent document, the provisions of the Public Works Standards shall control.

**10-2-5 Adopted.** Amendments

The international fire code is amended and changed in the following respects to meet the requirements set forth by the Utah state fire marshal's office in section R710-9-3 of the state fire rules and regulations. The following international fire code standards are amended as follows:

- A. International fire code standard 10-1, selection, installation, maintenance, and testing of portable fire extinguishers is amended to adopt NFPA, standard 10, 2022 edition.
- B. International fire code standard 10-2, installation, maintenance and use of fire protection signaling systems is amended to adopt NFPA, standard 72, 2019 edition.
- C. International fire code standard 52-1, compressed natural gas (CNG) vehicular fuel systems is amended to adopt NFPA, standard 52, 2019 edition.
- D. International fire code standard 79-1, foam fire-protection systems is amended to adopt NFPA, standard 11, 2021 edition.
- E. International fire code standard 82-1, liquefied petroleum gas storage and use is amended to adopt NFPA, standard 58, 2020 edition.

**SECTION TWO:** The ordinance shall take effect immediately upon posting.
