

## **ORDINANCE 2023-23**

### **ESTABLISHING A TIME AND PLACE FOR HOLDING REGULAR MEETINGS FOR THE 2024 CALENDAR YEAR.**

Be it ordained by the governing body of the municipality of NORTH OGDEN CITY.

**SECTION 1. TIME AND PLACE OF REGULAR COUNCIL MEETINGS, PLANNING COMMISSION MEETINGS, REDEVELOPMENT COMMITTEE MEETINGS (RDA), COMMERCIAL DEVELOPMENT COMMITTEE MEETINGS (CDA), ECONOMIC COMMITTEE MEETINGS (EDC), GENERAL PLAN ADVISORY COMMITTEE MEETINGS, ART'S GUILD MEETINGS, BARKER PARK COMMITTEE, CITIZEN BUDGET SUBCOMMITTEE, AND AUDIT COMMITTEE MEETINGS** The governing body (City Council) shall conduct regular meeting(s), which shall be held as follows: The second and fourth Tuesday of every month shall be a regular meeting and the first and third Tuesday of every month may be used for a work session as needed. The Planning Commission (The Land Use Authority) shall conduct regular meeting(s), which shall be held as follows: The first and third Wednesday of every month shall be a Regular meeting unless otherwise noted.

The governing body meeting(s) shall begin promptly at 6:00 pm Mountain Standard Time and at 6:00 pm during Mountain Daylight Time.

The Planning Commission, aka The Land Use Authority meeting(s), shall begin promptly at 6:00 pm during Mountain Standard Time and at 6:00 pm during Mountain Daylight Time.

The Audit Committee will meet quarterly at 6:00 pm on a Thursday.

The Barker Park Committee will meet on the fourth Wednesday of each month at 6:00 pm.

The RDA, CDA, Art's Guild, Economic Development Committee (EDC), Citizen Budget Subcommittee, and General Plan Advisory Committee will meet when called upon.




