

ORDINANCE 2019-32

ESTABLISHING A TIME AND PLACE FOR HOLDING REGULAR MEETINGS FOR THE 2020 CALENDAR YEAR.

Be it ordained by the governing body of the municipality of NORTH OGDEN CITY.

SECTION 1. TIME AND PLACE OF REGULAR COUNCIL MEETINGS, AND PLANNING COMMISSION MEETINGS. The governing body shall conduct regular meeting(s), which shall be held as follows: The second and fourth Tuesday of every month shall be a Regular meeting unless otherwise noted and the first Tuesday of every month for a work session as needed and the Planning Commission aka The Land Use Authority shall conduct regular meeting(s), which shall be held as follows: The first and third Wednesday of every month shall be a Regular meeting unless otherwise noted.
